Rio de Janeiro, January 30th, 2019 Vale S.A. ( Vale ) clarifies that in July 2016 the beneficiation process of the Córrego de Feijão mine shifted to dry processing and, therefore, the Dam I stopped receiving the disposal of tailings from the above-mentioned mine, becoming deactivated since then.
