The sole member and manager of WAM is Wolverine Holdings, L.P. ("Wolverine Holdings"). In addition to shares deemed beneficially owned by WAM, Wolverine Holdings may be deemed to be the beneficial owner of (i) 19,160 shares of common stock of the Issuer plus (ii) 20,700 shares of common stock receivable upon exercise of options of the Issuer held by affiliates other than WAM as of December 31, 2018. Robert R. Bellick and Christopher L. Gust may be deemed to control Wolverine Trading Partners, Inc. ("WTP"), the general partner of Wolverine Holdings.
