Other than as set forth below, the Reporting Persons currently have no plan or proposal which relates to or would result in any of the actions or transactions described in paragraphs (a) through (j) of Item 4 of the instructions to this Report.

On May 1 2007, the Reporting Persons sent a letter to the Board of Directors seeking the resignation of the current board members and seeking to appoint a slate of directors recommended by the two largest equity shareholders. In addition, the Reporting Persons asked how management will respond to the default letters, and what proactive steps management is undertaking to seek financing alternatives for the company. A copy of the letter is attached as Exhibit 1.
