Item 1.01. Entry into a Material Definitive Agreement.

On November 20, 2012, Martin Midstream Partners L.P. (the “Partnership”) entered into an underwriting agreement (the “Underwriting Agreement”) with RBC Capital Markets, LLC, Merrill Lynch, Pierce, Fenner & Smith Incorporated, UBS Securities LLC and Wells Fargo Securities, LLC, as representatives of the several underwriters named therein (collectively, the “Underwriters”), in connection with an underwritten public offering (the “Offering”) of 3,000,000 common units representing limited partner interests in the Partnership (“Common Units”) at a price of \$31.16 per Common Unit before an underwriting discount of \$1.2464 per Common Unit. Pursuant to the Underwriting Agreement, the Partnership has granted the Underwriters a 30-day option to purchase up to an additional 450,000 Common Units in connection with the Offering. The Partnership’s Offering of the Common Units has been registered under the Securities Act of 1933, as amended (the “Securities Act”), pursuant to a registration statement on Form S-3 (File No. 333-183481), as supplemented by a Prospectus Supplement dated November 20, 2012 pursuant to Rule 424(b) of the Securities Act

The Partnership has agreed to indemnify the Underwriters against certain liabilities, including liabilities under the Securities Act, or to contribute to payments the Underwriters may be required to make because of any of those liabilities.

The Partnership will use the anticipated net proceeds of approximately \$91.2 million from the Offering, plus up to an additional \$13.8 million if the underwriters exercise their option to purchase additional units in full, to repay outstanding indebtedness incurred under its revolving credit facility, including indebtedness incurred in connection with our purchase of certain assets from Cross Oil Refining & Marketing, Inc. and our purchase of all of the remaining Class A interests in Redbird Gas Storage LLC, a natural gas storage joint venture, from Martin Underground Storage Inc., each a subsidiary of Martin Resource Management Corporation, on October 2, 2012, and for general partnership purposes.

Neither this Current Report on Form 8-K, nor the attached press release, constitutes an offer to sell or a solicitation of an offer to buy the securities described herein, nor shall there be any sale of these securities in any state or jurisdiction in which such an offer, solicitation or sale would be unlawful prior to registration or qualification under the securities laws of any such jurisdiction. The Offering is being made only by means of a prospectus and related prospectus supplement.

The foregoing description is qualified in its entirety by reference to the full text of the Underwriting Agreement, which is filed as Exhibit 1.1 to this Current Report on Form 8-K and incorporated herein by reference. In addition, filed herewith are certain legal opinions issued by Locke Lord LLP in connection with the Offering.
