Represents restricted stock awards granted effective February 23, 2016 with respect to which sale or transfer rights will vest over a three-year performance period commencing on January 1, 2016 and ending on December 31, 2018. Vesting of these shares is dependent upon the attainment of pre-established performance objectives, and any difference between shares granted and shares earned at the end of the performance period will be reported at the conclusion of the performance period in 2019.

(3) Represents the difference between performance shares, with a three year performance period, that were granted on March 11, 2013 and actual shares earned at the end of the performance period on December 31, 2015. Final shares were approved by the Compensation Committee on February 23, 2016.

(4) Represents securities delivered in payment of a tax liability with respect to vesting of securities issued in accordance with Rule 16b-3.

(5) Represents the weighted average sale price of multiple open market same day sales with prices ranging from \$55.97 to \$56.6125 per share.
