- (2) 1992 Stock Incentive Plan: This amount includes stock units acquired pursuant to a dividend equivalent reinvestment feature on the H.B. Fuller Company 1992 Stock Incentive Plan.
- (3) 1992 Stock Incentive Plan: This option vests in four equal installments beginning on December 2, 1999.
