- (1) 401(k) Plan: This amount includes shares and dividends acquired pursuant to the H.B. Fuller Company Thrift Plan.  
2000 Stock Incentive Plan: 2,704 restricted shares were awarded pursuant to H.B. Fuller Company's 2000 Stock Incentive Plan and vest effective December 1, 2008. Total amount also includes restricted shares acquired pursuant to a dividend accrual feature of the 2000 Stock Incentive Plan.
- (3) Amended and Restated 2000 Stock Incentive Plan: 1,666 restricted shares were awarded pursuant to H.B. Fuller Company's Amended and Restated 2000 Stock Incentive Plan and vest effective December 4, 2009. This amount also includes restricted shares acquired pursuant to a dividend accrual feature of the 2000 Stock Incentive Plan.
