Each Common OP Unit acquired upon conversion of an LTIP Unit may be presented for redemption at the election of the holder, for cash equal to the fair market value of a share of the Issuer's Common Stock, except that the Issuer may, at its election, acquire each Common OP Unit so presented for one share of Common Stock.

- (2) The 186,006 LTIP Units vest over four years: 25% on January 1, 2015 and 25% each January 1st thereafter.
