- (1) Restricted shares awarded to Mr. Powers which will vest in two equal installments of 11,250 shares on March 15, 2006 and June 15, 2006.
- (2) Mr. Powers did not pay for the shares in question; they were awarded to him pursuant to the Issuer's non-employee director compensation policy. 12,500 shares were awarded for his service as a board member; and 6,250 were awarded for his service as Chairman of the Compensation Committee; and 3,750 were awarded for his service on the Audit Committee. The date of award was a federal holiday; on February 21, 2006, the next trading day, the closing price of the subject shares was \$0.41 per share.
