On February 8, 2007, General Dynamics announced that effective April 9, 2007, Bryan T. Moss will resign as executive vice president for the company's Aerospace group and president of Gulfstream Aerospace Corporation. Mr. Moss will serve as president emeritus of Gulfstream Aerospace Corporation until March 31, 2008. In connection with this change in position, Mr. Moss will receive a bonus in March 2008 equal to approximately 50 percent of his March 2007 bonus award and a bonus in March 2009 equal to approximately 25 percent of his March 2007 bonus award.
