INTRODUCTORY STATEMENT

STATEMENT UNDER GENERAL INSTRUCTION E REGISTRATION OF ADDITIONAL SHARES

The additional shares to be registered by this Registration Statement are of the same class as those securities covered by Open Joint Stock Company Vimpel-Communications (VimpelCom) and VC ESOP N.V. s (VC ESOP) previously filed registration statements on Form S-8 (Registration Nos. 333-13008, 333-125027 and 33-137105) as filed with the U.S. Securities and Exchange Commission on December 22, 2000, May 15, 2005 and September 5, 2006, respectively (collectively the Registration Statements), with respect to the VimpelCom 2000 Stock Option Plan (as amended, restated and renamed the Amended and Restated VimpelCom 2000 Stock Option Plan on December 19, 2003, and amended on April 29, 2005, April 28, 2006 and June 27, 2006) (collectively referred to as the Plan). Pursuant to General Instruction E to Form S-8, the contents of the Registration Statements, including reports under the Securities Exchange Act of 1934, as amended, as well as any amendments that VimpelCom filed after the dates of the Registration Statements to maintain current information about VimpelCom, are incorporated herein by reference.

Amendment Number Four to the Plan was approved by VimpelCom s board of directors on December 14, 2006, by VC ESOP s board of directors on March 12, 2007 and by VC ESOP s shareholders on April 3, 2007. The amendment increased the number of shares available for issuance under the Plan from 650,000 to 1,050,000 shares.
