Item 1.01 Entry into a Material Agreement.

On June 29, 2010, Arrowhead Research Corporation (the Company) and Unidym, Inc. (Unidym), its majority owned subsidiary, entered into a Subscription Agreement (the Subscription Agreement) whereby Unidym issued 4,785,077 shares of Unidym is Series D Preferred Stock (the Series D Shares) to the Company, in exchange for the cancellation of \$1,435,523 in accumulated operational loans by Arrowhead to Unidym. The Series D stock has a purchase price of \$0.30 per share. Series D Stock has a \$0.30 per share liquidation preference and each Series D Share is convertible into one share of Unidym common stock. After giving effect to the transaction, the Company is ownership of Unidym was 79% of outstanding voting securities and 64% of securities on a fully diluted basis.
