This Amendment No. 5 to Schedule 13D (this <u>Amendment</u>) relates to shares of common stock, par value \$0.01 per share (the <u>Common Stock</u>), of Lands End, Inc., a Delaware corporation (the Issuer). This Amendment amends the Schedule 13D, as previously amended, filed with the Securities and Exchange Commission by ESL Partners, L.P., a Delaware limited partnership (<u>Partners</u>), SPE I Partners, LP, a Delaware limited partnership (<u>SPE Master I</u>), RBS Partners, L.P., a Delaware limited partnership (<u>RBS</u>), ESL Institutional Partners, L.P., a Delaware limited partnership (<u>RBS</u>), ESL Institutional Partners, L.P., a Delaware limited partnership (<u>RBSIM</u>), CRK Partners, LLC, a Delaware limited liability company (<u>RBSIM</u>), CRK Partners, LLC, a Delaware limited States citizen, by furnishing the information set forth below. Except as otherwise specified in this Amendment, all previous Items are unchanged. Capitalized terms used herein which are not defined herein have the meanings given to them in the Schedule 13D, as previously amended, filed with the Securities and Exchange Commission.

Item 3. Source and Amount of Funds or Other Consideration.

In open market purchases on September 24, 2015, September 25, 2015, September 28, 2015 and September 29, 2015, Mr. Lampert acquired an aggregate of 460,219 shares of Common Stock for aggregate consideration of approximately \$12,342,504 (excluding commissions) using personal funds.
