Item 2.02. Results of Operations and Financial Condition

On February 22, 2017, Entercom Communications Corp. (the **Company**) issued a press release (the **Press Release**) announcing fourth quarter 2016 results. Specifically, for the fourth quarter of 2016 the Company announced:

net revenues of \$123.2 million; station operating expenses of \$81.5 million; corporate general and administrative expenses of \$8.4 million; operating income of \$30.0 million; and net income available to common shareholders of \$10.8 million. net income available to common shareholders per share basic of \$0.28 and diluted of \$0.27. In addition, the Company announced that for the year ended December 31, 2016: net revenues of \$460.2 million; station operating expenses of \$318.7 million; corporate general and administrative expenses of \$33.3 million; operating income of \$98.1 million; and net income available to common shareholders of \$36.2 million.

net income available to common shareholders per share basic of \$0.94 and diluted of \$0.91. A copy of the Press Release is attached as Exhibit 99.1 to this Current Report on Form 8-K.
