On July 28, 2008, the pre-paid variable forward arrangement (the "Transaction"), which the reporting person had entered into on August 6, 2007 with an unrelated party (the "Buyer") relating to 392,253 shares of common stock of Celgene Corporation ("Common Stock"),

(1) was terminated at the settlement price of \$73.51 per share. In connection with that termination, the reporting person delivered 337,261 shares of Common Stock to the Buyer, which shares had been previously pledged to the Buyer to secure his obligations under the Transaction.
