- (1) The number of shares of common stock that was previously reported by the reporting persons has been adjusted to reflect the one-for-fifteen reverse stock split of the common stock that occurred on December 10, 2010 (the "Reverse Stock Split").  
 On December 10, 2010, Merrill Lynch, Pierce, Fenner & Smith Incorporated ("MLPFS"), a wholly owned subsidiary of Merrill Lynch & Co., Inc., a wholly owned subsidiary of Bank of America Corporation, converted a Convertible Promissory Note in the principal amount of \$300,000 (the "Note"), including accrued interest thereon, pursuant to the Note's terms into 63,551 shares of common stock.
- (2) Pursuant to the Note's anti-dilution provisions (and after giving effect to the Reverse Stock Split), the Note was convertible into shares of common stock at the price per share at which the issuer sold common stock in its public offering that commenced on December 10, 2010, \$5.00 per share. Absent such anti-dilution provisions, the Note would have been convertible into shares of common stock at the rate of \$7.50 per share.
- (3) The transactions reported on this Form 4 were effected by MLPFS.

If not first converted, the Note would have matured on the earlier of: (a) March 15, 2011 and (b) the date that Uni-Pixel successfully raised \$10,000,000 in aggregate gross proceeds pursuant to one or more equity financings, which occurred on December 15, 2010.
