- (1) 25% of the options vest annually in four equal installments beginning on the first anniversary of the date of grant. In addition, all the options vest fully upon a change in control and the occurrence of certain events of the Issuer.

These shares represent a grant of restricted stock units under the Company's 2007 Omnibus Incentive Plan on August 18, 2016. This grant was made in lieu of cash fees for non-employee director service on the Company's board of directors for the third and fourth quarters of 2016. Fifty percent (50%) of the restricted stock units subject to the award vest at the end of the third quarter on September 30, 2016, and the remaining fifty percent (50%) vest at the end of the fourth quarter on December 31, 2016, subject to the reporting person's continuous service as a director.
