- (1) The Stock Options were fully vested on the grant date.

- (4) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/30/07.
- (5) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/29/08.
- (6) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/28/09.

The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and stock upon the Reporting Person's termination as a director of the Issuer.

(9) Represents phantom stock units accrued under the Weeks Corporation 1998 Deferred Compensation Plan. Between January 28, 2005 and April 1, 2005, the Reporting Person acquired 25 phantom stock units through dividend reinvestment. All amounts accrued under the plan are to be paid in cash upon the Reporting Person's termination as a director of the Issuer.
