REPORTS ON OPERATIONS  
FOR THE SECOND QUARTER AND SIX MONTHS ENDED JANUARY 31, 2009

J. W. Mays, Inc. today reported its financial results for the three and six months ended January 31, 2009.

Revenues for the three months ended January 31, 2009 were \$4,496,895 compared to revenues of \$3,735,444, in the comparable 2008 three month period, while revenues for the current six months were \$8,419,741 compared to revenues of \$7,212,651 in the comparable 2008 six months.

Net income for the three months ended January 31, 2009 was \$260,596, or \$.13 per share, compared to net loss of (\$244,680), or (\$.12) per share, in the comparable 2008 three month period.

Net income for the six months ended January 31, 2009 was \$320,934, or \$.16 per share, compared to net loss of (\$280,818), or (\$.14) per share, in the comparable 2008 six month period.
