Pine Bluff, AR -- Simmons First National Corporation's Board of Directors declared a regular \$0.24 per share quarterly cash dividend payable October 1, 2002, to shareholders of record September 16, 2002. This dividend represents a \$0.02 per share, or 9.09% increase over the dividend paid for the same period in 2001.
