#### DEREGISTRATION OF SECURITIES

On September 20, 2000, Universal Compression Holdings, Inc., a Delaware corporation, filed a registration statement on Form S-3 (No. 333-46208) covering the sale of 500,000 shares of Universal's common stock, par value \$.01 per share, from time to time by selling stockholders named in the prospectus. This registration statement was filed to register the sale of a portion of the shares of Universal common stock issued to the former stockholders of Gas Compression Services, Inc., which was acquired by Universal on September 15, 2000. On October 30, 2000, Universal filed a pre-effective amendment to the registration statement, and the Commission declared it effective on November 2, 2000. The remaining shares issued to the former stockholders of Gas Compression Services, Inc. were covered under another registration statement on Form S-3 (No. 333-50302) filed on November 20, 2000.

In accordance with the undertaking contained in Part II, Item  $17\,(A)\,(3)$  of the registration statement pursuant to Item  $512\,(a)\,(3)$  of Regulation S-K, Universal is filing this post-effective amendment to remove from registration all of the shares that remain unsold under the registration statement as of the date hereof. Universal is deregistering these shares because its obligation to maintain the effectiveness of the registration statement pursuant to the terms of the Registration Agreement between Universal and the selling stockholders, dated September 15, 2000, has expired.

Accordingly, Universal is filing this Post-Effective Amendment No. 1 to the Registration Statements on Form S-3 to deregister the number of shares of its common stock covered by the registration statement that remain unsold as of the date hereof.
