Mr. Maltese directly owned 1,000 shares of Common Stock. By reason of his position as Managing Member of (ii) MCM, Mr. Maltese may also be deemed to beneficially own 539,700 shares of Common Stock, constituting, in the aggregate, approximately 5.41% of the shares outstanding.
