PCP Gulf Invest 3 Limited ("PCP 3") is the direct beneficial owner of 758,437,618 of the Ordinary Shares reported herein. PCP 1 and PCP 3 are wholly owned subsidiaries of Kadin Holdings Ltd. ("Kadin"), which in turn is a wholly owned subsidiary of International Petroleum Investment Company ("IPIC"). Pursuant to the rules and regulations of the Securities and Exchange Commission, IPIC and Kadin may be deemed to be beneficial owners of the Ordinary Shares of which PCP 3 has direct beneficial ownership.
