NARRATIVE

State below in reasonable detail the reasons why Forms 10-K, 11-K, 20-F, 10-Q, N-SAR, N-CSR, or the transition report portion thereof, could not be filed within the prescribed time period.

As reported in its Current Reports on Form 8-K filed with the Securities and Exchange Commission (the "SEC") on February 27, 2003 and March 20, 2003, HEALTHSOUTH Corporation (the "Company") disclosed that the SEC and the Department of Justice (the "DOJ") were investigating the financial reporting and related activity of the Company. As reported in its Current Report on Form 8-K filed with the SEC on March 26, 2003, the Company announced that in light of the SEC and DOJ investigations into its financial reporting and related activity calling into question the accuracy of the Company's previously filed financial statements, such financial statements should no longer be relied upon. In addition, the Company announced that it engaged a forensic review team from PricewaterhouseCoopers LLP to review the Company's prior financial statements. As reported in its Current Report on Form 8-K filed with the SEC on January 20, 2004, the Company announced that the forensic review by PricewaterhouseCoopers LLP is substantially complete, and its Special Audit Review Committee is preparing a report regarding the forensic review. In addition, the Company announced that it retained Grant Thornton to assist in the reconstruction of the Company's financial accounts.

As a result of the foregoing, the Company is unable to complete the preparation of its financial statements for the period ended March 31, 2004 and, therefore, will not be able to file its Quarterly Report on Form 10-Q for the period ended March 31, 2004 on a timely basis.

As reported in its Current Report on Form 8-K filed with the SEC on March 16, 2004, the Company disclosed that it does not expect to be in a position to file its restated historical financial statements for prior periods with the SEC until the Company has completed the reconstruction of its financial records and Pricewaterhouse Coopers completes its audit. The Company currently estimates that such financial statements will not be completed until the first quarter of 2005.
